(Revenue \$) DUE TO THE PANDEMIC, DIRECT STUDENT SUPPORT WAS ESPECIALLY CRITICAL TO HELP KEEP STUDENTS IN SCHOOL AND SUCCEEDING. \$109,046.53 WAS AWARDED TO 178 STUDENTS THROUGH THE STUDENT EMERGENCY FUND TO ASSIST WITH BASIC NEEDS SUCH AS HOUSING AND FOOD INSECURITY, A 92% OR 270 STUDENTS INCREASE IN THE AMOUNT SPENT ON STUDENTS OVER THE PRIOR YEAR. SCHOLARSHIP SUPPORT WAS ALSO IMPORTANT AND 843 STUDENTS IN THE FOUR LOS RIOS COLLEGES RECEIVED A SCHOLARSHIP PROVIDED BY GENEROUS INDIVIDUALS, CORPORATIONS, FOUNDATIONS AND EMPLOYEES. SCHOLARSHIPS COVER TUITION FEES, TEXTBOOKS, TRANSPORTATION AND LIVING EXPENSES FOR STUDENTS WITH A HIGH LEVEL OF FINANCIAL NEED AND/OR OUTSTANDING ACADMEIC PERFORMANCE. THE SCHOLARSHIP PROGRAM SUPPORTS DESERVING STUDENTS INCLUDING FOSTER YOUTH, VETERANS, SINGLE PARENTS AND AT-RISK LOW INCOME POPULATIONS.

GENEROUS CORPORATE AND INDIVIDUAL DONORS COMMITTED TO SCHOLARSHIPS FOR CURRENT STUDENTS AND TO ESTABLISHING THE LOS RIOS PROMISE ENDOWMENT TO SUPPORT STUDENTS IN PERPETUITY. THE FIRST COHORT OF 110 STUDENTS HAD AN 81.6% PERSISTANCE RATE COMPARED TO 66.5% OF THE AVERAGE LOS RIOS STUDENT POPULATION.
